If your product is distributed through broadline distribution, please indicate what distribution centers stock your product.

Once all completed information is received by our Supplier Diversity Department, your company information will be forwarded to the Supply Manager and Operations Support for review.

The appropriate supply management team member will review your information for its potential application along with division representatives, if necessary. Responses may include one of the following:

**Immediate Need:** This is an area of opportunity we are interested in pursuing and we will contact you shortly.

**Future Need:** We may already be under contract for your product or service. Your company's information will be maintained for a future bid.

**No Need:** Our company does not use sufficient volume of your product/service. There is no opportunity at the current time.

An individual from the Supplier Diversity Department will contact you to inform you of the response from Supply Management and the next steps for your company.

A contract must be established in order to be an approved supplier for Sodexo. Prior to any award of business, all vendors must meet our insurance, QA audit and indemnity requirements.
